# GRAYDON GROUP INSTALLS HIGH SPEED IN GITAU

The community of Gitau will have high speed internet access, also to be known at the Kitselas Community Network, beginning as soon as April 2010. The company installing the new broadband technology is the Graydon Group.

Gitau which currently operates on dial-up internet service, or wireless internet (similar to cell phone reception) will finally be enabled to have high speed internet, like our neighbours across the highway.

The cost which customers will have to pay is

actually comparable or lower than high speed internet rates in Terrace. Starting at \$39.95/month for 1800/850Mbs-30 Download Max.

# OUR CHILDREN ARE OUR RESPONSIBILITY

Recently there have been numerous meetings held between the Northwest Inter-Nation Family and Community Service Society, Kitselas Band, Ministry of Children and Family Development and also community members.

During these collaborative networking meetings, the focus has been the best interests of the children who are in care or who are in transition from being in care, apprehended and foster homes. This is an important issue because NIFCS will be taking the reins from MCFD in the near future, they are hoping for a November 2010.

For the best interest of the children, an Aboriginal child should be placed in an Aboriginal home, if available. Currently, this is not consistently followed by MCFD. In order for this to

possible, community volunteers need to come forth and become informed on what is required to become eligible to be foster parent or safe house.

Currently MCFD controls how and when Aboriginal children are taken into government care. NIFCS has been working continually towards self-reliance when it comes to Aboriginal children apprehension and foster home care, which can be directly linked into the ongoing Treaty negotiations. Other first nations that have reached a Treaty have protocols already set up to address this issue.

There are meetings taking place on a regular basis, and it is important to our community and our children.

This workshop will bring awareness on how to recognize the signs of suicide, how and where to get help for their loved ones.

Unfortunately, small first nations communities are often faced with dealing with suicide far more often than non-aboriginal communities. Becoming informed and educated on this important topic helps everyone in the community.

Suicide rates are five to seven times higher for First Nations youth than for non-Aboriginal youth.

# RECENT AMENDMENTS TO THE INDIAN ACT

The last major revision of the *Indian Act* occurred in 1985. Since that time, however, there have been further amendments to the legislation.

In 1988, the Act was changed to allow bands greater powers to tax land interests on their reserves, as well as permitted individuals to mortgage these leaseholds on reserves. The purpose of these reforms was to provide bands with access to revenues and financing in order to promote economic development on reserves.

The 1990s and early 2000s saw renewed efforts on the part of the federal government to significantly revise the *Indian Act*. In the early 1990s, the federal government announced its intention to eventually abolish the *Indian Act*. As part of this policy, the government introduced the *Indian Act Optional Modification Act* in 1996.

The proposed legislation included modifications to the Indian Act in several areas, such as the system of the band governance, bylaw authority, and the regulation of reserve land and resources. The Act faced strong opposition from Aboriginal groups, and was never passed by Parliament.

In 2002, the federal government again initiated a major overhaul of the Indian Act with the introduction of *The First Nations Governance Act*. Central to the new Act was the requirement that Aboriginal bands develop a system by which to choose their leaders, as well as clear rules regarding how band money is spent.



Furthermore, under the Act, the actions of Aboriginal bands would no longer be exempt from the *Canadian Charter of Rights and Freedoms*. Again, however, the new Act faced opposition from Aboriginal groups and was never passed by Parliament. For more information on *The First Nations Governance Act*:

While these large overhaul packages were never passed, the federal government did implement more narrow revisions of the Indian Act during this period. In 1999, it enacted *The First Nations Land Management Act* (FNLMA). Previously, reserve land management, such as environmental standards and land use policies, was governed by provisions of the *Indian Act*. Under the FNLMA, however, bands can apply to the federal government to assume control over land management on their reserves. The purpose of the legislation is to improve band capacities and opportunities for economic development.

Furthermore, in 2000, the *Indian Act* was amended to allow band members living off-reserve to vote in band elections and referenda.

This amendment was in response to a 1999 Supreme Court of Canada decision which concluded that the denial of voting rights for off-reserve band members violated their right to equality under Section 15 of the *Canadian Charter of Rights and Freedoms* [13].

When you make an appointment to have your hearing checked, you will have to **pay** a service fee in town. When you need to have your hearing checked, just ask your Dr. to be referred to the Hearing clinic at the Skeena Health. **You will not have to pay the service fee.** Their program is pretty good. Their hearing aids are up to par, meaning the hearing aids are invisible to the eye, no one will know you are wearing them!! Sound good, give it a try and check them out. There are a lot of things you can do with their hearing aid kits, you can adapt them to listening to music, watching television, or even speaking on the phone. Mind you, there is a waiting list, but guaranteed, you will be satisfied.
